- 3) If you have been divorced, submit Statement of divorce including dates, reasons.
- 4) Application signed & notarized on the back sheet.
- 5) After phone conference the following will be sent for you to sign and or initial including: Application, ARC Articles of Faith, & Constitution, Ministers Code of Ethics form, & ARC Discipline form.

## **CERTIFICATE AND IDENTIFICATION CARD...**

An approval packet and credential card will be sent to you with the Board of Directors approval.
